General Terms and Conditions for Konig UK Training Courses

1. Registration and confirmation

Registration for participation in a training course must be made either in writing or verbally to our training manager. After checking availability and payment terms/payment has been received, you will receive booking confirmation via email to confirm your place on the course.

2. Terms of Payment - Proforma Customer on a general course

After confirming a date, you will receive a proforma invoice for payment. This proforma invoice is **not** confirmation of your place on the course. Your place is confirmed once payment has been made. Upon receiving payment we will send you an official booking confirmation. If other places are paid for before yours, they will take priority which means the date you originally booked might now be unavailable. To avoid disappointment we recommend paying immediately. If payment hasn't been made 14 days before the start of the training course, **your place will be cancelled**. For bookings made within 14 days of the training course, payment has to be made immediately.

3. Terms of Payment - Account Customer on a general course

After confirming a date, we have to receive an official purchase order to confirm your place on the course. Agreement on a date is **not** confirmation of your place on the course. Your place is not confirmed until an official purchase order has been received. Upon receiving an official purchase order we will send you an official booking confirmation. If an official purchase order hasn't been received 14 days before the start of the training course, **your place will be cancelled**. For bookings made within 14 days of the training course, an official purchase order has to be sent immediately.

4. Terms of Payment – Bespoke/On-Site courses

After confirming a date, we either have to receive payment immediately or receive an official purchase order immediately. If this does not happen, the date may be given out to other customers.

5. Rebooking/Withdrawal

You can withdraw your registration for a training course at any time. This can only be done if payment is yet to be made or an official purchase is yet to be received.

Once payment has been made, you can rebook or cancel your training course confirmation free of charge up to 14 days before the course date for a general course. Within 14 days of the course date, rebooking or cancellation of a training course will occur a fee. This fee is the full cost of the training course. For a bespoke/on-site course you can rebook or cancel your training course for free of charge up to 28 days before the course start date. Within 14 days of the course date, rebooking or cancellation of a training course will occur a fee. This fee is the full cost of the training course.

6. Cancellation by Konig UK

Should Konig UK have to cancel a training course for organisational reasons, no claims for damages can be made however we will take reasonable action to compensate. In this case, the training course fee will either be refunded or an alternate date agreed.

7. Number of Participants – Bespoke/On-Site courses

Whereby a number of participants has been agreed beforehand, this must be adhered to wherever possible. If number of participants changes for whatever reason, this might result in a fee or even cancellation of the course.
