# **Universal Maintenance Lacquer**

#### **Intended Use**

- To maintain the value of thick layer glazed wood windows (application recommended every six months).
- · To renovate foiled UPVC windows after weathering.
- Provides a new sheen to window frames and extends renovation intervals.
- For indoor and outdoor use.

#### Characteristics

- · Physically drying, waterborne lacquer.
- · Very simple and uncomplicated to use.
- Dries rapidly.
- UV-protection, resistant to yellowing.
- Soil-resistant and water-repellent protective coating.
- Sheen level: silk gloss.

#### **Application Notes**

Shake container well before use. Surface to be treated must be dry and free of grease. If necessary, clean with Eco-Cleaner. Test Universal Maintenance Lacquer on an inconspicuous area first to ensure compatibility with the surface. Do not use Universal Maintenance Lacquer in direct sunlight or on surfaces that are heated up. Processing temperature 12-25°C.

Pour Universal Maintenance Lacquer into a flat bowl, soak Maintenance Sponge or sponge cloth and spread material extensively on the surface. Strip off sparsely, just once lengthwise, do not polish.

After a few minutes the treated area will be dry and after approx. 30 minutes hard-wearing. Wash out Maintenance Sponge/sponge cloth with water after use.

Even <u>UPVC windows</u> (foiled), which have become dull and matt by environmental influences, can be refurbished with Universal Maintenance Lacquer again and again.
